### Commissioners Reports:

Mayor Russo — He reported that there is some discussion about creating a bike share in Downbeach. Engineer Carter and Solicitor Agnellini also discussed the bike share. Solicitor Agnellini noted that this type of project might require a request for bids. Engineer Carter noted that it might be a unique situation for a downbeach coalition for bids. Mayor Russo also announced that there is an Easter Egg Hunt scheduled for this Saturday beginning at 10:45 am at Borough Hall.

Commissioner Lawler had no reports.

Engineer Carter reviewed his Engineering report for the workshop.

Engineer Carter requested a report on the record regarding the water tower litigation. Solicitor Agnellini noted that there was no written document on the closed session other than the minutes from that closed session. Solicitor Agnellini summed up the session that the attorney handling the case did not find it fiscally responsible to proceed with the case. Commissioner Lawler was satisfied with that report.

Engineer Carter continued discussion and review of the engineer's report.

Engineer Carter noted that he would like to discuss the McGee site remediation project with the solicitor. Solicitor Agnellini will reach out to attorney associated with the project.

Engineer Carter noted that the dune project has been delayed approximately two weeks and that it might be an item for discussion with the state. Mayor Russo noted that he recommends that if the project is further delayed that it begin in a north to south direction. Commissioner Lawler was in support of that recommendation.

Engineer Carter continued to review the engineer's report.

With no further business to discuss, Commissioner Lawler made a motion to adjourn, with a second by Mayor Russo. ALL IN FAVOR – YES. None opposed. Commissioner Leeds - Absent.
