Resolution 2016-46 A RESOLUTION AUTHORIZING PAYMENT OF ACCUMULATED SICK TIME

Whereas, the Borough of Longport (the "Borough") has received notice from Acting Lt. Joseph Baumgardner that he will retire effective April 30, 2016 ("Retirement Effective Date"); and

Whereas, pursuant to the Borough's agreement with the Policemen's Benevolent Association, Local 363 dated April 8, 2015 the Borough is obligated to pay Acting Lt. Joseph Baumgardner for unused sick time at the rate of \$55.62 per hour ("Sick Time Rate"); and

Whereas, Acting Lt. Joseph Baumgardner has a current accumulated unused sick time balance equal to 1521.00 hours creating a projected total payout obligation to Acting Lt. Joseph Baumgardner equal to \$84,598.02 assuming that no additional sick time is utilized by Acting Lt. Joseph Baumgardner prior to the Retirement Effective Date; and

Whereas, the amount of sick time paid out to Acting Lt. Joseph Baumgardner, anticipated to be \$84,598.02, will be budgeted in the 2016 Police Department Salary and Wage budget;

Now Therefore Be It Resolved, that the Board of Commissioners of the Borough of Longport authorizes the Borough Chief Financial Officer to pay Acting Lt. Joseph Baumgardner the Sick Time Rate for the number of sick and vacation time hours accumulated as of the Retirement Effective Date which total amount is anticipated to be \$84,598.02.
