

**BOROUGH OF LONGPORT
RESOLUTION 2017-67**

**AUTHORIZING THE CITY'S PARTICIPATION IN THE NATIONAL JOINT POWERS ALLIANCE (NJPA)
FOR RFP#032515-CHN, CONSTRUCTION AND AGRICULTURAL EQUIPMENT WITH PEACH COUNTRY
TRACTOR.**

WHEREAS, the Borough of Longport is allowed to participate in national purchasing cooperative per N.J.S.A. 52:34-6.2 (b) P.L. 2011, c.139 which was enacted into law permitting agencies to utilize national purchasing cooperatives; and

WHEREAS, the National Joint Powers Alliance (NJPA) as the lead agency and awarded RFP# 032515-CHN, to purchase Construction and Agricultural Equipment; and

WHEREAS, the Department of Public Works is in need of a one (1) Skid Steer for beach and dune maintenance on the Borough on beaches; and

WHEREAS, William Trinkle, Supervisor of Public Works and Jenna Kelly, CFMO/QPA, Chief Financial Officer have researched the available Skid Steers and determined that the New Holland C232 unit is a functional economic vehicle for the Borough of Longport; and

WHEREAS, William Trinkle, Supervisor of Public Works and Jenna Kelly, CFMO/QPA, Chief Financial Officer have reviewed the contract from National Joint Powers Alliance (NJPA) RFP#032515-CHN, Construction and Agricultural Equipment with the award vendor Peach Country Tractor.; and

WHEREAS, it is recommended that the Borough Commission approve the purchase of one (1) model year 2017 or newer New Holland C232 Skid Steer for use by the Department of Public Works for daily work operations throughout the Borough from Peach Country Tractor.; and

NOW THEREFORE, BE IT RESOLVED by the Borough Commissioner of the Borough of Longport, New Jersey, that one (1) model year 2017 or newer New Holland C232 Skid Steer Vehicle for use by the Department of Public Work be purchased from Peach Country Tractor, NJPA Contract Vendor #032515-CHN as follows:
