**WHEREAS**, after a water test on various leak locations at Municipal Hall, it was determined that it will be necessary to perform certain caulking and sealing of window and flashing areas; and

**WHEREAS**, the Municipal Engineer met with and obtained a Proposal, dated June 03, 2017 from **Coastal Caulking and Restoration I, LLC** in the amount of \$5,800.00, which Proposal is attached hereto; and

**WHEREAS**, the Municipal Engineer has reviewed said Proposal and is herewith recommending that the Proposal be adopted by the Governing Body.

**NOW, THEREFORE, BE IT RESOLVED** by the Longport Borough Board of Commissioners that the aforementioned recommendation is hereby accepted and that said Governing Body hereby awards a Contract to **Coastal Caulking and Restoration I, LLC** of Ocean City, N.J. for the caulking and sealing of various locations at Municipal Hall for the Total Amount of **\$5,800.00** as stated in their Proposal dated June 03, 2017; and

**BE IT FURTHER RESOLVED**, that the Municipal Chief Finance Officer is hereby directed to issue the required Purchase Order to **Coastal Caulking and Restoration I,LLC**; and the Municipal Engineer is hereby directed to authorize the Contractor to proceed with said work, all in accordance with the aforementioned Proposal.

**BE IT FURTHER RESOLVED** that a Certificate of Available Funds has been issued by the Chief Financial Official and is attached to this Resolution as required by Law..
