## AUTHORIZING THE BOROUGH'S PARTICIPATION IN THE HELPING GOVERNMENT ACROSS THE COUNTRY BUY (HGACBUY) FOR AM10-16, AMBULANCES, EMS AND OTHER SPECIAL VEHICLE SPECIALISTS WITH VCI EMERGENCY VEHICLES SPECIALISTS.

**WHEREAS**, the Government Across the Country Buy (HGACBuy) as the lead agency and awarded contract # AM-10-16, to purchase Ambulances, EMS and Other Special Vehicles; and

**WHEREAS**, the Longport Fire Department is in need of a one (1) Ambulance for Emergency Medical Service calls throughout the Borough; and

WHEREAS, Levon Clayton, Chief of the Fire Department and Jenna Kelly, CFMO/QPA, Chief Financial Officer have researched the available Ambulances and determined that the Type III, Ford E450, Model 553 unit is a functional vehicle for the Borough of Longport; and

WHEREAS, Levon Clayton, Chief of the Fire Department and Jenna Kelly, CFMO/QPA, Chief Financial Officer have reviewed the contract from Government Across the Country Buy (HGACBuy) Contract # AM10-16, Ambulances, EMS and Other Special Vehicle Specialists with the award vendor VCI Emergency Vehicles Specialists.; and

**WHEREAS**, it is recommended that the Borough Commission approve the purchase of one (1) model year 2018 or newer Type III, Ford E450, Model 553 Ambulance for use by the Longport Fire Department for Emergency Medical Calls throughout the Borough from VCI Emergency Vehicle Specialists.; and
