

**BOROUGH OF LONGPORT  
RESOLUTION 2017 –124  
APPOINTING MEMBERS TO THE BOROUGH OF LONGPORT FLOODPLAIN MANAGEMENT  
PUBLIC INFORMATION COMMITTEE**

**WHEREAS**, as an active participant in FEMA’s Community Rating System (CRS) program, the Borough of Longport has determined that it is necessary to form a Floodplain Management Public Information Committee, consisting of municipal officials and community stakeholders, to assist in evaluating existing information disseminated by the Borough regarding floodplain management, and to develop new public information needs; and

**WHEREAS**, flood insurance premium rates are discounted to reflect the reduced flood risk resulting from the community actions meeting the three goals of the CRS;

1. Reduce flood damage to insurable property
2. Strengthen and support the insurance aspects of the NFIP
3. Encourage a comprehensive approach to floodplain management

**WHEREAS**, the Community Rating System credits local initiatives to advise people about flood hazards, flood insurance, flood preparation and safety, the natural functions of floodplains and flood loss reduction measures; and

**WHEREAS**, the Borough currently participates in the Atlantic Cape Multi-Jurisdictional Program for Public Information, a local Floodplain Management Public Information Committee is required; and

**NOW, THEREFORE, BE IT RESOLVED** that the Governing Body of the Borough of Longport formally establish a Floodplain Management Public Information Committee to evaluate existing public information and develop new public information needs.
