RESOLUTION AWARDING PROFESSIONAL SERVICE CONTRACT

Website Annual Maintenance Contract

WHEREAS, the Borough of Longport has the need to enter into an Annual Maintenance Contract with City Connections, LLC of Barnegat, NJ who is the provider of our current website www.longportnj.gov ; and

WHEREAS, the local Public Contracts Law (N.J.S.A.40:11-1 et seq) exempts professional services from public advertising for bids which may be awarded by resolution of the Governing Body.

WHEREAS, City Connections, LLC., has already completed and submitted a Business Entity Disclosure Certification which certifies that the Firm and its members and employees have not made any reportable contributions to a political or candidate committee in the Borough of Longport in the previous one year, and that the contract will prohibit the Firm from making any reportable contributions through the term of the contract, and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Borough of Longport, in the County of Atlantic and the State of New Jersey, as follows:

1. The Mayor of the Borough of Longport is hereby directed to execute and deliver a professional service contract for a term of one year commencing January 1, 2017 to December 31, 2017, as follows:

Cost: \$5,336.00

2. Funds are available for this purpose and the required certificate of availability of funds issued by the Borough's Chief Financial Officer is annexed hereto.
