RESOLUTION #2018-02
TEMPORARY BUDGET FOR YEAR 2018

WHEREAS, the total appropriations in the 2017 budget exclusive of any appropriations made for interest and debt redemption charges, capital improvement fund and public assistance is the sum of \$6,678,205.08 in the Current Fund and \$1,029,200.00 in the Water/Sewer Utility Fund;

WHEREAS, twenty six and one quarter percent (26.25%) of the total appropriations in the 2017 budget, exclusive of any appropriations made for interest and debt redemption charges, capital improvement fund and public assistance in said 2018 budget is the sum of \$1,753,028.83 for the Current Fund and \$270,165 for the Water/Sewer Utility Fund;

THEREFORE, BE IT RESOLVED that the following appropriations shall constitute the temporary current and water and sewer budgets of the Borough of Longport for 2018:
