AWARD OF CONTRACT TO ATLATIC COAST ALARM, INC.
5100 HARDING HWY, SUITE 203, MAYS LANDING, NJ 08330
FOR A CHANGE ORDER TO THE
UPGRADING AND ADDITIONS TO THE EXISTING VIDEO SURVEILLANCE SYSTEM
At Longport Borough Hall and Public Works Garage and Firehouse

WHEREAS, the Borough of Longport received two informal bid for the **UPDGRADING AND ADDITIONS TO THE EXISTING SURVEILLANCE at Borough Hall and PW Garage**, which information is on file with the Chief financial Official; and

WHEREAS, the Commissioner of Public Safety had reviewed the Bid Proposals and had awarded a contract on June 18, 2019 to the apparent lowest responsible Bidder, **ATLANTIC COAST ALARM, INC.** of Mays Landing, New Jersey for their Total Bid Amount of **\$32,750.00**.

WHEREAS, a need for an additional three (3) cameras in the Fire Department has been requested by the Fire Chief and approved by the Municipal Administrator; and

WHEREAS, a change order in the amount \$2,900.00 is requested for the additional three cameras at the Firehouse; and

NOW, THEREFORE, BE IT RESOLVED by the Longport Borough Board of Commissioners that the recommendation of the Municipal Administrator is hereby accepted and that said Governing Body hereby awards, and the Chief Financial Officer is hereby authorized to execute Purchase Order/Contract for the **CHANGE ORDER FOR THE UPGRADING AND ADDITIONS TO THE EXISTING VIDEO SURVEILLANCE at Borough Hall and Public Works Garage and Firehouse to ATLANTIC COAST ALARM** of Mays Landing, New Jersey in the amount of **\$2900.00** for their Total Amount Bid of **\$35,650.00**; and

BE IT FURTHER RESOLVED that a Certificate of Availability of Funds from the Municipal Chief Financial Officer is attached hereto.
