AWARD OF CONTRACT FOR A STATE AID PROJECT
TO HACKNEY CONCRETE, INCORPORATED OF ATLANTIC CITY, N.J.
FOR THE MA 2017 ROADWAY AND DRAINAGE IMPROVEMENTS TO
29TH AVENUE
From Sunset Avenue to Risley's Channel

WHEREAS, the Municipal Purchasing Agent and Municipal Engineer, on the publicly advertised date and time of April 10, 2019 at 2:00 PM, opened six (6) Bid Proposals for the **MA 2017 ROADWAY AND DRAINAGE IMPROVEMENTS TO 29th AVENUE - From Sunset Avenue to Risley's Channel**; and

WHEREAS, the Municipal Engineer has reviewed the Bid Proposals; determined that the lowest apparent bid is within budget; and has recommended award to the apparent lowest responsible bidder, price and other factors being considered, **Hackney Concrete, Incorporated** of Atlantic City, New Jersey, for their **Total Amount Bid of \$136,501.00**.

NOW, THEREFORE, BE IT RESOLVED by the Longport Borough Board of Commissioners that the recommendation of the Municipal Engineer is hereby accepted and that said Governing Body hereby awards, subject to approval of the New Jersey Department of Transportation, a Contract to **Hackney Concrete, Incorporated** of Atlantic City, N.J. in an amount of **\$136,501.00** for the **MA 2017 Roadway and Drainage Improvements to 29th Avenue-From Sunset Avenue to Risley's Channel**, and

BE IT FURTHER RESOLVED, that the Longport Borough Board of Commissioners recommends to the New Jersey Department of Transportation that the contract for the **MA 2017 Roadway and Drainage Improvements to 29th Avenue - From Sunset Avenue to Risley's Channel** in the Borough of Longport, County of Atlantic be awarded to **Hackney Concrete, Incorporated** of Atlantic City, N.J. whose **Total Amount Bid** is **\$136,501.00**; and

BE IT FURTHER RESOLVED, that the Mayor be and is hereby directed to sign, and the Municipal Clerk directed to attest to with the Corporate Seal, the contract in the prescribed form for said construction; and

BE IT FURTHER RESOLVED that a Certificate of Available Funds has been issued by the Chief Financial Official and is attached to this Resolution as required by Law..
