**AUTHORIZING A PROFESSIONAL SERVICES CONTRACT
WITH A.W. PONZIO AND ASSOCIATES OF ATLANTIC CITY, N.J. FOR
DEVELOPMENT OF CONSTRUCTION DOCUMENTS & BID SPECIFICATIONS, BID
ADMINISTRATION & CONSTRUCTION ADMINISTRATION RELATING TO THE
FIRE BOAT LIFT AT THE MUNICIPAL RECREATION COMPLEX
2305 Atlantic Avenue at the Bay**

WHEREAS, the Borough of Longport has allocated Capital Improvement Funding for the installation of a Fire Boat Lift at the rear of Municipal Hall along Risley's Channel; and

WHEREAS, A. W. Ponzio and Associates has previously performed such work pertaining to Waterfront Development NJDEP Permitting, and

WHEREAS, the Borough desires to enter into a Professional Services Contract with **A.W. Ponzio and Associates** of Atlantic City, N.J. pursuant to the provisions of NJSA 19:44A-20.5; and

WHEREAS, the Professional Services are as outlined in a Proposal dated January 22, 2021 and shall not exceed \$ **11,000.00**; and

WHEREAS, the anticipated term of said Services is not for more than one year; and

WHEREAS, A.W. Ponzio and Associates has previously completed and submitted a Business Entity Disclosure Certification which certifies that **A.W. Ponzio and Associates** has not made any reportable contributions to a political or candidate committee in the Borough of Longport within the previous one year and, further, that this Contract will prohibit **A.W. Ponzio and Associates** from making any reportable contributions through the term of this Contract; and

WHEREAS, a Certificate of Availability of Funds has been issued by the Municipal Chief Financial Officer and is attached to this Resolution.

NOW, THEREFORE BE IT RESOLVED by the Governing Body of the Borough of Longport that it hereby accepts the Proposal dated January 22, 2021 with **A.W. Ponzio and Associates** for a Not to Exceed amount of **\$11,000.00** and hereby directs the Administrator to authorize **A.W. Ponzio and Associates** to proceed with the work as outlined in said Proposal; and

BE IT FURTHER RESOLVED that a Notice of this Contract Award shall be published at least once in the Atlantic City Press pursuant to the requirements of Chapter 198 of the New Jersey Laws of 1971.
