

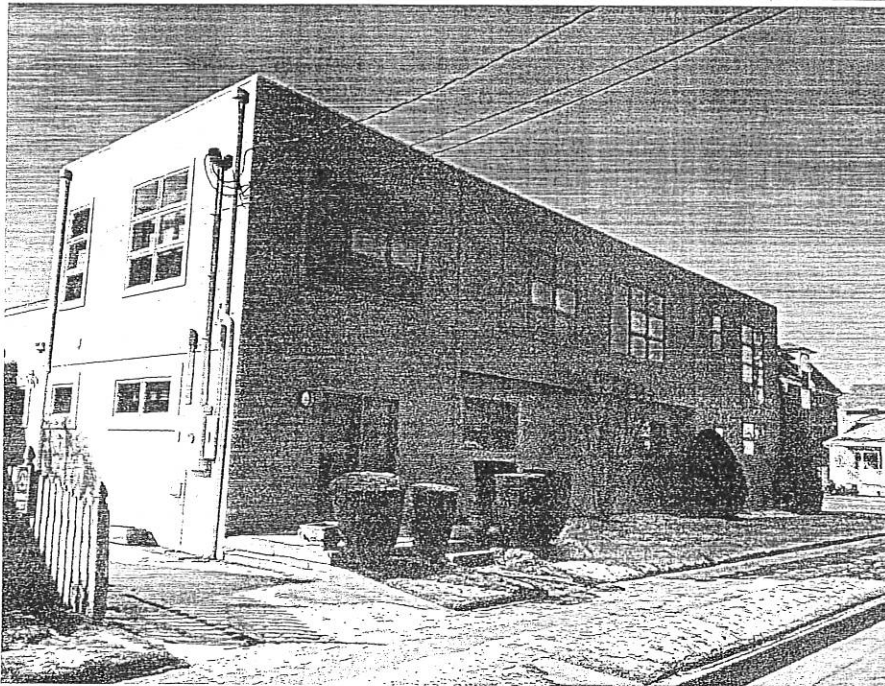

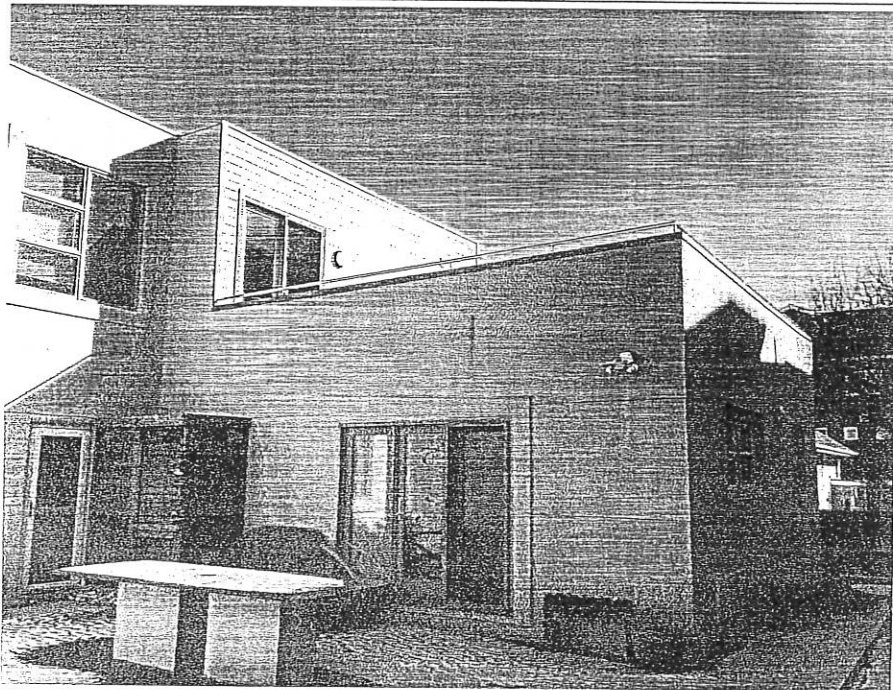

Photo One Caption LEFT SIDE VIEW 1/2/18

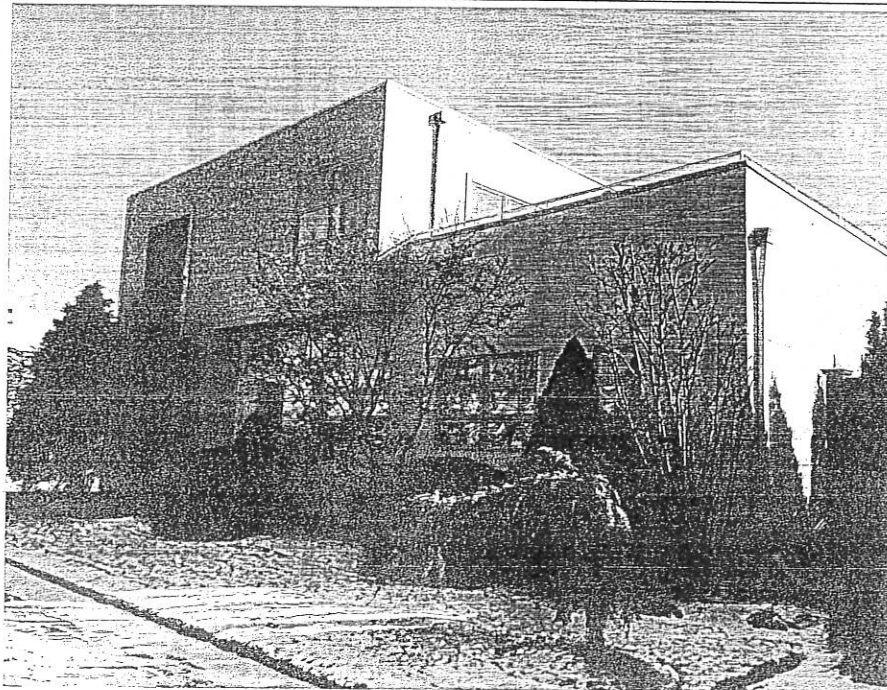
