## **BOAT LICENSE APPLICATION**

### **Longport Code 64-6**

Every owner of every boat, (defined in 64-4. See attached Ordinance), shall be required to obtain a license from the Borough of Longport before bringing or permitting to be brought or using any boat as herein defined on any beach or in the surf in the Borough of Longport.

### **Longport Code 64-8**

- A. The Clerk of the Borough of Longport shall provide application forms for all licenses. Saif forms shall provide as follows:
  - 1. Applicants shall be at least 18 years of age and residents of the Borough of Longport
  - 2. The boat shall not be more than 18 feet in length, and a complete description, together with copy of bill of sale, setting forth make, number (if any), color of hull, color of sails and design, shall accompany the application.
  - 3. The licenses to be issued by the Borough shall not be transferable and shall be valid for a one year period.
- B. Each owner shall submit to the Clerk, together with the application, a paid-up insurance policy covering liability for injury to any person or persons in the amount of \$50,000/\$100,000
- C. License number decals issued by the Borough of Longport shall be permanently painted on or attached to the side of the boat.

## Chapter 64. BOATS

### Article II. Use and Operation

#### § 64-4. Definitions.

The following definitions shall apply to this article:

**BOAT**

A vessel or watercraft capable of being used as a means of transportation on water and propelled wholly by sails or muscular power. Specifically excluded from use upon the beaches are boats or power vessels temporarily or permanently equipped with machinery for propulsion.

**OPERATE**

To navigate or otherwise use a boat.

**OWNER**

A person other than a lienholder having the property interest in or title to a boat. The term includes a person entitled to the use or possession of the boat.
