

**BOROUGH OF LONGPORT
ORDINANCE 2017-24
AN ORDINANCE AMENDING CHAPTER 61 BEACHES, PARKS, RECREATIONAL AREAS
OF THE BOROUGH OF LONGPORT CODE**

Purpose.

An ordinance to establish fees and fines for the Longport Public Library.

SECTION I. The Title for Chapter 61 is hereby revised to read **Chapter 61 BEACHES, PARKS, RECREATIONAL AREAS, AND FACILITIES.**

SECTION II. The following Article is added to Chapter 61:

**ARTICLE IX
LIBRARY FEES AND FINES**

61-87. Library Fees and Fines.

A. Fines for late material

- a. Books, magazines – 10 cents per day
- b. DVD’s – Children & Family .25 cents per day
All other DVD’s \$1.00 per day

B. Fees for services

- a. Copies
 - 1. 10 cents for black & white copies
 - 2. 25 cents for color copies

C. Misc fees

- a. Coffee/tea/hot chocolate - \$1.00 per cup
- b. Book Sale -50 cents/paperback & \$1 per hardback

SECTION III: All other Ordinances or parts of Ordinances which are inconsistent with the provisions of this Ordinance, to the extent of such inconsistencies, are hereby repealed. Should any section, subsection, clause, or portion of this Ordinance be adjudged by a Court of competent jurisdiction as invalid, such judgment shall not affect, impair, or invalidate the remainder of this Ordinance.

SECTION IV: This Ordinance shall take effect immediately upon passage and publication as required by Law.
